New Dealer Registration Policies

Maintaining a Dealer-Only Wholesale Marketplace

• **<u>PHOTO I.D. REQUIRED</u>**. Each week when arriving, in order to receive a bidder badge each dealer must present their dealer card, driver's license (or other form of photo ID), in order to receive a bidder badge. A security guard will be posted at the entry doors to the arena and the gate coming on to the lot and NO ENTRY WILL BE GRANTED UNLESS YOU HAVE A BIDDER BADGE.

Why This Rule? Some dealers have loaned their dealer cards to retail/public buyers who have bid on cars and not paid for them

• <u>THREE REP RULE.</u> All dealers will be allowed to authorize three (3) authorized buyer/sellers on their account in a period of 12 months. Additional authorizations will cost \$250 per person.

Why This Rule? To prevent dealers from bringing in retail buyers as reps and destroying YOUR dealer-only wholesale market.

- <u>MECHANIC/HELPER RULE</u>. Dealers will be allowed to add TWO (2) mechanics per year to their account who must receive a dealer mechanic badge each week to gain entry to auction arena.
- **DRIVERS NOT ALLOWED IN AUCTION ARENA**. Bidder badges will only be granted to authorized dealers, reps, and mechanics. DRIVERS WILL NOT BE GRANTED ACCESS TO THE AUCTION ARENA. They will be allowed on the lot when presenting a valid gate pass.
- <u>GUEST PASS</u>. As of February 1st 2013, guest passes will only be issued if pre-approved at least 24 hours in advance by a manager and/or dealer registration prior to sale day. There will be NO exceptions to this rule!
